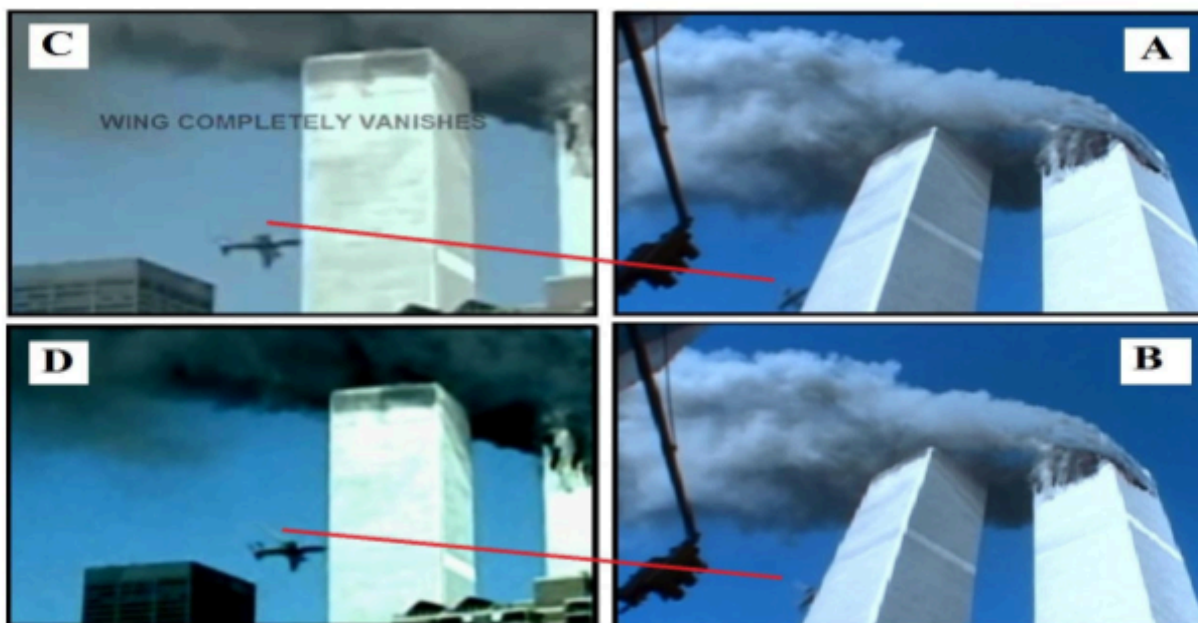

Disappearing & Reappearing Wing Study

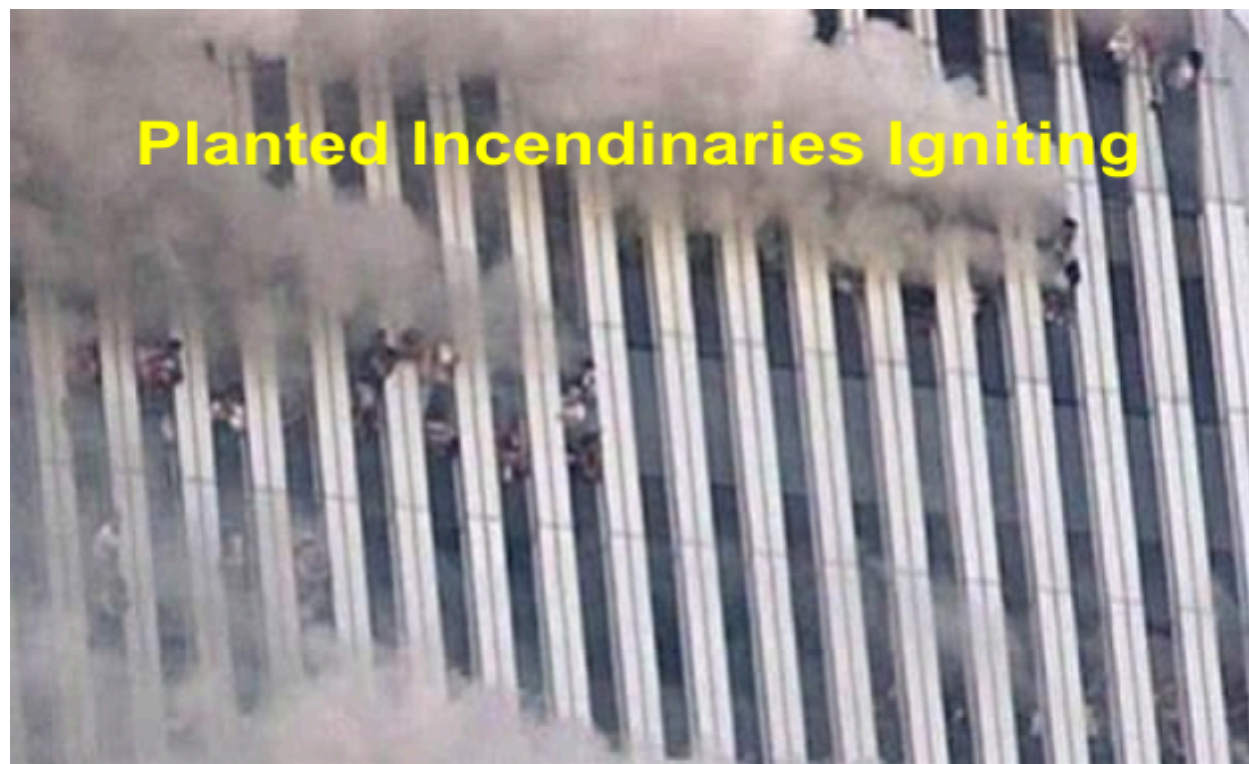

The World Trade Center Tragedy Was Orchestrated By The Deep State



The events of September 11, 2001, have been the subject of much debate and conspiracy theories. This article aims to explore some claims made by individuals who argue that there were no commercial plane crashes on 9/11. By examining various pieces of evidence and arguments put forth by these individuals, we can gain a more profound understanding of the different perspectives surrounding this tragic event.

I retired from Verizon and worked in telecommunications. I assisted a customer several times with several complicated issues with phones he didn't own. It turns out the federal government had employed him with the extremely high-security clearance of Q. A Q clearance is a type of security clearance used by the U.S. Department of Energy to grant access to Top Secret Restricted Data, Formerly Restricted Data, and National Security Information, as well as Secret Restricted Data. He entered the private sector and opened several security businesses. He doesn't own a phone or computer, he cannot have any electronic footprints. None. When I found out what he did for a living, we started discussing that there were no commercial plane crashes on 911 and the Deep State. He said, for the most part, I was definitely on the right track. Some issues, he was not at liberty to discuss.

I recently found an article in the archives on my phone when I was looking for something else. I thought I had lost it. This was written about 6 months after 911 by James Fetzer who is a Distinguished McKnight University Professor Emeritus at the University of Minnesota, Duluth. He retired from the university in 2006. The article was deleted soon after I read it. This certainly offers food for thought. Everything in quotation marks after my explanation of the Deep State is Mr. Fetzer's research. Who was responsible for 911 and why?

I read from other sources that about 7 months before 911 Israeli art students were in the twin towers. They were, in truth, demolition experts and planted military-grade thermite and perhaps mini-nukes in all the support structures. I asked the search engine, "Were there any traces of thermite?" Here are the results." There are claims that active thermitic material was discovered in the dust from the World Trade Center catastrophe. However, these claims are not widely accepted and have been challenged by other sources. Weeks before 911 there were many stretched limousines, the "elite" planners of the operation rented high-end suites, so they could "watch the show". WTC 7 was their command center and had to be destroyed.

The main purpose given was to give us a reason to attack Iraq and Afghanistan. We went into Iraq to get Saddam Hussein's weapons of mass destruction; none were found. Afghanistan was to capture Osama bin Laden. The real reason was to gain control of Iraq's oil and control Afghanistan's poppy fields. I watched a video of a military official whose job was to protect the poppy fields. The Deep State is responsible for the heroin explosion in this nation.

In this manuscript, I'm going to explain my perception of whom the Deep State are, who comprises them, their methods of operation, what they have done, and how they are being defeated.

“The reason the families will never ask for verification of plane debris from any of the 4 planes from any of the 4 locations on 911 is that there were no commercial plane crashes on 911.”

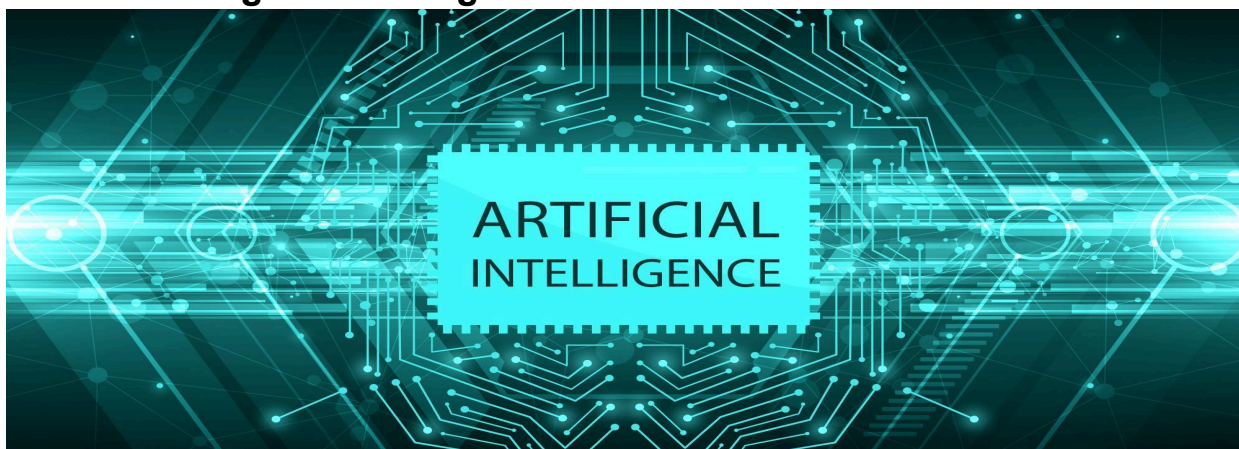
“The reason that not one single family member gave or demanded a DNA sample or independent test from the planes on 911 is that there were no commercial plane crashes on 911.”

A.Rosie O'Donnell, a former co-host of ABC talk show The View, did make comments on the show about the collapse of World Trade Center 7, which was not hit by a plane on 9/11. She suggested that the building could not have fallen due to fire alone, and that explosives must have been involved. However, I couldn't find any information to support the claim that she was fired specifically for mentioning WTC 7. Is there anything else you would like to know?

Q.“Numerous news stations reported the WTC 7 collapse BEFORE IT HAPPENED.”

A.Yes, there are reports that the BBC reported the collapse of World Trade Center Building 7 before it actually occurred. The network relied on an incorrect report from Reuters, for which Reuters later issued a correction. The scene on 9/11 was chaotic, and BBC staff were talking directly to the emergency services and monitoring local and national media. There was a fairly consistent picture being painted of Building 7 in danger of collapse. Is there anything else you would like to know?

Q.“The reason hundreds of “terrorist training drills” like Tripod II and Vigilant Guardian were taking place on 911,..at the exact time of the plane crashes. It was for plausible deniability.”

A.Yes, there were several military exercises and drills planned for September 11, 2001. These included **Operation Northern Vigilance**, which involved deploying fighter aircraft to locations in Alaska and Northern Canada¹, and **Vigilant Guardian**, a semiannual NORAD exercise that had been running with Global Guardian for several days and which postulated a bomber attack from the former

Soviet Union. There was also an exercise known as ****Operation Tripod**** which was due to take place on September 12, 2001, set up to test the plan to distribute antibiotics to the entire city population during a bioterrorism attack¹. Is there anything else you would like to know?

Q.“The reason that none of the voice data recorders, flight data recorders, or black boxes had serial numbers, a first in aviation history, and it happened 4 times on the same day.”

A.According to my sources, both recorders were recovered from Flight 77, which crashed into the Pentagon, and both recorders were also recovered from Flight 93, which crashed in Pennsylvania. However, no credible sources reported the recovery of any recorders from the World Trade Center site. Is there anything else you would like to know?

Q.“The reason that Every TV interview on the day of 911 was given by a military-owned media outlet personnel.”

A.I couldn't find any information to support the claim that every TV interview on the day of 9/11 was given by military-owned media outlet personnel. However, there were reports of retired military officers being used by the Pentagon to shape terrorism coverage from inside the TV and radio, networks. Is there anything else you would like to know?

Q.“The reason that all the buildings and locations on 911 appear to have been destroyed by some form of demolition or directed energy weapon (there was no jet fuel).”

A.There is no credible evidence to support the claim that the buildings and locations on 9/11 were destroyed by some form of demolition or directed energy weapon. The National Institute of Standards and Technology (NIST) conducted a thorough investigation into the collapse of the World Trade Center towers and concluded that the collapse was caused by a combination of factors, including the impact of the planes, the resulting fires, and the structural damage caused by both. Is there anything else you would like to know?

Q.“The reason the US government allocated only \$3 million dollars to investigate all of 9-11 (the Lewinsky Scandal got \$50 million).”

A.The 9/11 Commission, also known as the National Commission on Terrorist Attacks Upon the United States, was initially given a budget of ****\$3 million**** to complete a full report of the circumstances of the events of 9/11 and provide recommendations to guard against future attacks.

Q.“The reason NORAD stood down on 911 to immediately intercept the planes was that there were no planes to shoot down.”

A. There is no credible evidence to support the claim that NORAD was ordered to “stand down” on 9/11. NORAD's standard operating procedure on 9/11 was to scramble fighter jets to intercept any aircraft that deviated from its flight path or lost radio contact. On the morning of 9/11, NORAD followed this procedure and scrambled fighter jets in response to the hijackings. Is there anything else you would like to know?

I performed a Google search.

Thus, NORAD stood down. NORAD's job is to protect American airspace. However, on the morning of 9/11, Vice President Dick Cheney was controlling operations. It was the first time in U.S. history that a president, or vice president, was in direct control of the military agency. NORAD's job is to protect American airspace.

Q. “The reason: Every video filming the Pentagon was immediately confiscated (80+ at last count).”

A. According to my sources, the FBI did confiscate video footage from security cameras near the Pentagon on 9/11. In a freedom of information lawsuit filed by Scott Bingham, FBI special agent Jacqueline McGuire testified that she inspected 85 videotapes to find evidence for 9/11 investigators. Eighty-four of these tapes remain withheld. However, the FBI has released some footage from security cameras at the Pentagon. Is there anything else you would like to know?

Q. “The reason the command procedure to shoot down a rogue plane was changed just weeks before 9-11 was to get Donald Rumsfeld’s permission first, and then was changed back immediately the day After 911 at the pilot's discretion.”

A. I couldn't find any information to support the claim that the command procedure to shoot down a rogue plane was changed just weeks before 9/11 to require Donald Rumsfeld's permission first. On 9/11, Vice President Dick Cheney did authorize the military to shoot down hijacked commercial aircraft, but this decision was made during the first hour after the attacks, when it was unclear how many passenger jets had been weaponized by terrorists and aimed at America's seats of power. Is there anything else you would like to know?

Q. “The reason that None of the 256 passengers drove and parked their cars at Any airport on 911.”

A. I couldn't find any information to support the claim that none of the 256 passengers drove and parked their cars at any airport on 9/11. Is there anything else you would like to know?

Q. “The reason that Not One single video exists of any person (except Atta) at

any airport in any way from any of the planes of 9-11.”

A.I couldn't find any information to support the claim that not one single video exists of any person, at any airport in any way, from any of the planes of 9/11. Is there anything else you would like to know?

Q.“The reason that Tens of millions of dollars were made on “put options” which shorted United and American Airlines just days before 9-11, and the US Refuses to release exactly who made those financial bets.”

A.There were reports of unusual trading activity in the days leading up to 9/11 involving put options for United and American Airlines, the two airlines whose planes were hijacked during the attacks. Put options are financial instruments that allow investors to profit when the price of a stock falls. In the days before 9/11, there was a significant increase in the number of put options purchased for United and American Airlines stock, indicating that some investors may have had advance knowledge of the attacks. However, the US government has not released information about who made those financial bets³. Is there anything else you would like to know?

Q.“The reason the US conducted a terrorist training drill at the Buffalo Intel Airport one week Before 911 which included terrorists blowing up a plane (the exact people conducting this drill just so happen to be the ones who then conducted the “rescues” at the ground zero one week later!) was that there were no commercial plane crashes on 911.”

A.On September 10, 2001, Donald Rumsfeld announced that the Pentagon could not account for \$2.3 trillion in past transactions. However, it is not true that all 28 accounting experts died in the Pentagon plane attack and all investigations were immediately dropped. In fact, there is no evidence to support this claim. Is there anything else you would like to know?

Q.“The reason the Pentagon was conducting a “Masca” (Mass Casualty) exercise On The Day Of 911 at the Pentagon involving a Plane Crashing Into, was once again for a weak plausible deniability excuse because there were no

commercial plane crashes on 911.”

A.The Pentagon Mass Casualty project (code-named Pentagon Mascall) was a contingency exercise that was held in the Office of the Secretary of Defense conference room between October 24 and October 26, 2000. The exercise required emergency response teams, members of the defense protective services, and U.S. government officials to conduct emergency simulations in preparation for a possible plane crash into the Pentagon. However, this exercise did not take place on September 11, 2001. Is there anything else you would like to know?

Q.“The reason the doors, fire escapes, observation decks, and All access to the top TC’s 1 and 2 buildings were closed and chained up on Monday 9-10-01, was because survivors could talk because there were no commercial plane crashes on 911.”

A.I apologize, but I couldn't find any information to support the claim that the doors, fire escapes, observation decks, and all access to the top of the Twin Towers were closed and chained up on Monday, September 10, 2001. Is there anything else you would like to know?

Q.“The reason Mayor Gulliani was conducting Operation Tripod II at Pier 92 (rather than a new multiple million dollar bunkers inside WTC 7) on Monday 9-10-01 which involved terrorist attacks on the WTC and then the same people were then in charge of 911. A.On September 12, 2001, Pier 92 was scheduled to have a drill called Operation Tripod II, which was a bioterrorism exercise. Various individuals were invited to watch, including Mayor Rudolph Giuliani, the police and fire commissioners, and representatives of the FBI and the Federal Emergency Management Agency (FEMA). Pier 92 was set up as a model distribution station where the “victims” of the mock attack who needed to receive antibiotics would be treated.

A.The FBI released information about the 9/11 hijackers in the days following the attacks. However, I couldn't find any information to support the claim that the FBI released all the details you mentioned (names, addresses, photos, religious beliefs, hereabouts, affiliations, professional connections, flight training schools,

nationalities, personal histories, ages, and visa status) within days of 9/11. Is there anything else you would like to know?

Q.“The reason Pa. Gov. Tom Ridge, who would then head a new agency called Homeland Security, said that the WTC debris would be buried at CDI’s smelting plant which was purchased just months before 911 in PA (no debris went overseas or to China for example!) was because there were no commercial plane crashes on 911.”

A.I apologize, but I couldn't find any information to support the claim that Pennsylvania Governor Tom Ridge said that the WTC debris would be buried at CDI’s smelting plant in Pennsylvania and that no debris went overseas or to China. Is there anything else you would like to know?

Q.“Even though it was illegal, Gulliani banned all photography and video of the WTCs after the attacks, which clearly showed serious problems with the official stories.”

A.I couldn't find any information to support the claim that Mayor Giuliani banned all photography and video of the WTC after the 9/11 attacks.

Q.“The reason Osama bin Laden denies any connection to wrongdoing and basically says the US government and military are sick and murderous for their aims, is because he had nothing to do with 911.”

A.Yes, Osama bin Laden initially denied any involvement in the 9/11 attacks. In a statement issued to the Arabic satellite channel Al Jazeera on September 16, 2001, bin Laden said, “I would like to assure the world that I did not plan the recent attacks, which seems to have been planned by people for personal reasons”

Q.“The reason there were serious issues with All the videos showing planes on 911 is that there were no commercial plane crashes on 911.”

A.There is no evidence to suggest that there were serious issues with the videos showing planes on 9/11. The footage of the planes hitting the Twin Towers was captured by multiple sources and widely broadcasted. Is there anything else you would like to know?

Q.“The reason that there will always be massive issues with the passenger lists and why not ONE of the hijackers was listed on any of them is because there were no commercial plane crashes on 911.”

A.There is no evidence to propose that there were any issues with the passenger lists of the flights hijacked on 9/11. The names of the hijackers were not on the passenger manifests because they used fake identities and fraudulent

documents to purchase their tickets and board the planes. Is there anything else you would like to know?

Q.“The reason there will never be a single piece of verified debris from any of the 4 planes from any of the 4 locations on 911 is that there were no commercial plane crashes on 911.”

A.No, that is not true. There was verified debris from all four planes found at all four crash sites on 9/11. For example, at the Pentagon, there are numerous photos that show airplane debris at the site of the attack, including a piece of damaged metal with text on it that says, “American Airlines, Inc.”. Is there anything else you would like to know?

Q.“The reason that no engines, no tail sections, no seats, no fuselage, no luggage, and nothing from any of the planes have ever been found and verified through a serial number is that there were no commercial plane crashes on 911.”

A.No, that is not true. There was verified debris from all four planes found at all four crash sites on 9/11. For example, at the Pentagon, there are numerous photos that show airplane debris at the site of the attack, including a piece of damaged metal with text on it that says, “American Airlines, Inc.”. Is there anything else you would like to know?

Q.Serial numbers?

A.There were many pieces of debris from the planes that were found and verified through serial numbers. For example, a 5ft piece of metal, which bears a Boeing label and serial number, was found wedged between two New York City buildings and is believed to be part of the landing gear of one of the jets flown into the World Trade Center on 9/11. Is there anything else you would like to know?

Q.I asked when the landing gear was found?

A. 5-foot-long piece of landing gear from one of the planes that crashed into the World Trade Center on 9/11 was found on April 26, 2013, wedged between two buildings in Lower Manhattan. The piece of metal bears a Boeing label and serial number. Is there anything else you would like to know?

Q.“The reason there are massive issues with the take-off records of the 4 flights on 911 is that there were no commercial plane crashes on 9-11. And have never been physically verified, since there were no commercial plane crashes on 911.”

A.There is no evidence to suggest that there were any issues with the take-off records of the four flights hijacked on 9/11. The flights took off as scheduled from their respective airports.

Q. "The reason \$15 billion dollars was paid out to the US airline companies within 2 weeks of 9/11 was because there were no commercial plane crashes on 9/11."

A. Yes, that is correct. Following the 9/11 attacks, Congress passed a measure for a \$15 billion financial aid package to help the crippled airline industry

Q. "The reason the airline insurance companies have yet to pay a single penny to replace a single plane from 9/11 (which by the way they ONLY pay by debris verification), is because there were no commercial plane crashes on 9/11."

A. I couldn't find any information to support the claim that airline insurance companies have yet to pay a single penny to replace a single plane from 9/11. In fact, according to the Insurance Information Institute, 9/11 was the largest claims payout in global insurance history, with insured losses of about \$32.5 billion. Is there anything else you would like to know? Q. I asked Bing if the insurers actually paid the \$95 million.

However, the settlement agreement was described in papers filed in Manhattan federal court, and it is standard practice for parties to fulfill the terms of a legal settlement. “Because of inquiries by Nafeez Ahmed (2002), Thierry Meyssan (2002), Paul Thompson (2004), Michael Ruppert (2004), and David Ray Griffin (2004, 2005), among others, we already know that the official account of 9/11 cannot possibly be correct. That account contends that 19 Arabs, with feeble ability to pilot aircraft, hijacked four airliners and then executed demanding maneuvers to impact the World Trade Center and the Pentagon, that the damage created by their impact combined with the heat from burning jet fuel brought down WTC1 and WTC2; that WTC7 was the first building in history to be brought down by fire alone; and that the Pentagon was struck by United Flight 77, which was a Boeing 757. The basic problem with this “conspiracy theory”, is that its truth would violate laws of physics and engineering that cannot be transgressed. The extremely high melting point of structural steel, about 2,800° F is far above the maximum, around 1,500° F, that could have been produced by jet fuel under optimal conditions. Underwriters Laboratory had certified the steel used in the World Trade Center to 2,000° F for up to six hours. Even lower maximum temperatures result after factoring in insulation, such as asbestos, and the availability of oxygen. Since steel is a good conductor, any heat applied to one part of the structure would have been dissipated to other parts. WTC1, the North Tower, was hit first at 8:46 AM/ET and collapsed at 10:28 AM/ET, whereas the South Tower, hit second at 9:03 AM/ET, collapsed at 9:59 AM/ET. They were exposed to fires for roughly an hour and a half and an hour, respectively. Insofar as most of the fuel was burned off in the gigantic fireballs that accompanied the initial impacts, that these towers were brought down by fuel fires that melted the steel is not just improbable but physically impossible.

Most Americans may not realize that no steel-structure high-rise building has ever collapsed from fire in the history of civil engineering, either before or after 9/11. If we assume that those fires have occurred in a wide variety of buildings under a broad range of conditions, that evidence suggests that these buildings do not have a propensity to collapse as an effect of fire. That makes an alternative explanation, especially the use of powerful explosives in a controlled demolition, a hypothesis that must be taken seriously. Indeed, there appear to be at least ten features of the collapse of the Twin Towers that are expectable effects of controlled demolitions but not from fires following aircraft impacts. They include that the buildings fell about the rate of free fall; that they both collapsed virtually straight down, and into their footprints; that almost all the concrete was turned into very fine dust; that the collapses were complete, leaving virtually no steel support columns standing; that photographic records of their collapse reflect “demolition waves” occurring just ahead of the collapsing floors; that most of the beams and columns fell in sections of 30' to 40' in length; that firemen reported hearing sequences of explosions as they took place; that seismological events were recorded immediately before collapse; and that pools of molten metal were observed in the sub-basements.

The Pentagon case should be the most accessible to study, since it depends solely upon observations and measurements, which are the most basic elements available for any scientific investigation. Indeed, photos taken before the collapse of the Pentagon's upper floors supply evidence that, whatever hit the Pentagon, it cannot possibly have been a Boeing 757. The plane was 155' long, with a wing span of 125' and stood 36' high with its wheels retracted. The initial point of impact, before the collapse of the floors above, was only about 10' high and 16' wide, about the size of the double doors on a mansion. A meticulous engineering study with careful measurements has been conducted that offers powerful evidence that the official story cannot possibly be correct. This was caused by the impact of a cruise missile."



Flight 93, Shanksville, Pa.



United Airlines Flight 93, a Boeing 757-222 operated by United Airlines, crashed on September 11, 2001, in Stony Creek Township, Somerset County, Pennsylvania. The plane was hijacked by four al-Qaeda terrorists who intended to crash it into a federal government building in Washington, D.C. However, the passengers fought back and forced the terrorists to crash the plane in a Pennsylvania field, thwarting their main objective. The crash site is now known as the Flight 93 National Memorial.

I asked Microsoft Bing, "What time did it crash?"

Q. Were any interceptors sent up for Flight 93?

According to a report by CBS News, two fighter pilots from the Air National Guard, Lieutenant General Marc Sasseville and Heather Penney, scrambled into their F-16s to intercept United Airlines Flight 93 after two planes hit the World Trade Center on September 11, 2001. However, they did not have enough time to arm their jets with missiles to take down the plane if necessary. The pilots were looking for a rogue airliner that was flying low and not communicating with air traffic control. The pilots did not receive orders from the chain of command to intercept Flight 93; they took it upon themselves to protect and defend the country. However, the passengers of Flight 93 fought back against the hijackers and drove the plane into a field in Shanksville, Pennsylvania, before the fighter jets could reach them.

Q. What do conspiracy theorists say about Flight 93?

A. Conspiracy theories about the events of September 11, 2001, including Flight 93, have been circulating since the attacks. Some conspiracy theorists assert that Flight 93 was destroyed by a heat-seeking missile from an F-16 or a mysterious white plane. Q. Did the passengers call anyone from their cell phones?

A. Yes, according to the National Park Service, thirteen passengers and crew members of United Airlines Flight 93 responded to the hijacking by placing phone calls to the authorities, United Airlines, and their family members and friends. The FBI reported that thirty-seven phone calls were placed from on board Flight 93 between 9:28 am when the plane was hijacked until the time of the crash at 10:03 am. Thirty-five of these calls were made on the Airfones located on the back of the seats in the last nine rows of the plane. Credit card records reveal the time of the call, Airfone caller’s name, the number of numbers dialed, the duration of the call, and the row from which the call was placed. These phone records were entered as evidence during the sentencing trial of Zacarias Moussaoui in 2006.

Q. So we can listen to the phone calls? If so, how do we request this information?

A. However, I’m sorry to inform you that there are no publicly available recordings of these phone calls. The FBI has released transcripts of some of these calls, but they have not released any audio recordings. If you would like to request additional information about these phone calls, you can contact the National

Transportation Safety Board (NTSB) or Federal Bureau of Investigation (FBI) for more information.

Q. Were the flight data recorders recovered?

A. According to the National Park Service, the flight data recorder of United Airlines Flight 93 was recovered on Thursday, September 13, 2001, at 4:20 am from the crater at a depth of 15 feet. The cockpit voice recorder was also recovered intact, as deep as 25 feet underground. The FBI took custody of both boxes and flew them to the National Transportation Safety Board (NTSB) headquarters in Washington, D.C. and then to the Honeywell facilities in Redmond, Washington, for evaluation and downloading.

Q. Is there any wreckage the public can view today?

According to the National Park Service, the crash site of United Airlines Flight 93 is now a national memorial and open to the public. The Flight 93 National Memorial is located in Stony creek Township, Somerset County, Pennsylvania, and covers an area of 2,200 acres. The memorial includes a visitor center, a Wall of Names, a Tower of Voices, and a field of honor. The visitor center features exhibits that tell the story of Flight 93 and its passengers and crew. The Wall of Names is a memorial that honors the passengers and crew members who died on Flight 93. The Tower of Voices is a 93-foot-tall musical instrument that contains 40 wind chimes that represent the voices of the passengers and crew members who died on Flight 93. However, I'm sorry to inform you that there are no wreckage pieces on display at the memorial. The crash site has been left untouched as a mark of respect for the victims and their families.

Q. Did the insurance company pay any claims to the airline for Flight 93?

A. Warren County Sheriff Brian Zeybel was one of the troopers that got the call the day after the attack to pull together uniforms and get on the road to Shanksville. His assignment was just three or four days long, the powers that be

been rotating officers through so no one was exposed to the scene for too long. Flight 93 struck the ground outside Shanksville, Pennsylvania at about a 40-degree angle and somewhere between 563 and 580 miles per hour, according to the National Park Service, carrying about 5,500 gallons of jet fuel. The impact created a crater 15 feet deep and about 30 feet across. The largest piece recovered intact was a 6-foot by 7 foot piece of the fuselage. The appearance of the site itself has stuck with Zeybel. "I was surprised, still am surprised, (about) the lack of evidence of a plane hitting the earth," he said. "In the way of debris fields and all that, the earth absorbed that pretty well, almost sucked it up." Zeybel explained that the plane crashed in a field near a forested edge. "You could see a 'V,' a demarcation line, from a divot in the earth where the fire went in there," he said. Presumably caused by the jet fuel, hundreds of trees were "half scorched on the right-hand side. (The fire) scorched everything in that 'V' instantaneously. The trees themselves looked like someone had painted half with fire retardant. That was odd for me. That to me looked odd. I've never seen anything like that, that hot, that fast, (that) could burn the side of a tree." "I expected to see stuff everywhere," he said. "It really wasn't like that, I think the angle, you think the earth as hard as it is, as light as a plane is, it flies, going at that speed at that angle," He compared the site to driving a nail into concrete." According to the NPS, the wreckage was "largely unrecognizable pieces of twisted metal, pieces of the landing gear of the plane, a tire, the frames of some seats, bits of charred paper, and remnants of luggage and clothing. Most of the pieces of wreckage were quite small, the size of a notebook or smaller."

Q. Who is John Carlin and what did he say about 911?

A. John Carlin is a journalist who wrote an article for The Independent in 2002 about the United Airlines Flight 93 crash in Shanksville, Pennsylvania. In his article, Carlin questions the official story of Flight 93 and suggests that the heroic story of the passengers on board may not be entirely true. He reports that Lee Purbaugh, who was present in the field where the plane crashed, saw the plane hit the ground and claims that he did not see any evidence of a struggle or fight on board. He was the only person present in the field where, at 10.06am, the aircraft hit the ground. “There was an incredibly loud rumbling sound and there it was, right there, right above my head, maybe 50ft up,” says Purbaugh, who works at a scrapyard overlooking the crash site. “It was only a split second, but it looked like it was moving in slow motion, like it took forever. I saw it rock from side to side then, suddenly, it dipped and dived nose first, with a gigantic explosion, into the ground. I knew immediately that no one could possibly have survived.”

Apart from, here and there, a finger, a toe, or a tooth, all that remained of the 44 souls aboard, churned into the soil or hanging from the branches of nearby trees, were small pieces of tissue and bone. The plane was also pulverized, reduced to tiny fragments of metal. Wally Miller, the local coroner in what used to be a forgotten corner of rural Pennsylvania, was the man charged by law with collecting the human remains and establishing the causes of death. “I issued the death certificates,” says Miller, who is also the local undertaker. “I put down 'murdered' for the 40 passengers and crew; 'suicide' for the four terrorists.” But Miller, who worked closely with the FBI during the 13 days that they investigated the crash site, admits that, ultimately, he cannot prove what happened; he can only infer it. Neither he nor anybody else knows what exactly caused Flight 93 to go down and, as Miller puts it, “bring the world's troubles crashing down on our doorstep”. Or, if there are people who do know, they are not telling. Vanity Fair magazine, going on little more information than was available to The New York Times, went ahead and published a highly detailed story on Flight 93, which, the magazine said, “may be remembered as one of the greatest tales of heroism ever told”. Vanity Fair did recognize, though, that any suggestions as to what actually happened to force the plane down had to be, by necessity, “pure conjecture”.

The article also claims that these families were behind the creation of the Fed in 1913 and that they have used their influence to manipulate monetary policy and global events for their benefit.

According to another article by The Event Chronicle, which cites Henderson's article as well as other sources, the Federal Reserve System is a cartel of private bankers who conspired to create a central bank that would serve their interests and enable them to create money out of thin air. They Caused The Great Depression



Some wealthy and powerful families contributed to the Great Depression by creating a great inequality between the rich and the poor. This imbalance led to overproduction and under consumption, as well as speculative investing and borrowing that fueled the stock market crash of 1929.

They thrived during the Great Depression and started new businesses. President Franklin Roosevelt's "New Deal" legislation somewhat helped, but the 2nd World War ended the depression by putting everybody back to work and making military armaments. The Lend-Lease Act enabled a struggling Great Britain to continue fighting against Germany virtually on its own until the United States entered World War II late in 1941. It also helped the Soviet Union withstand the Nazi invasion and eventually push them back to Berlin. The Soviet Union received a total of \$11.3 billion worth of material under the program, including 14,000 aircraft, 12,700 tanks, 375,883 cargo trucks, and 44,000 jeeps. The topic of Eisenhower's final speech was a warning against the establishment of a military-industrial complex, a term he coined to describe the conjunction of an immense military establishment and a large arms industry that could acquire unwarranted influence and power in American society. He also expressed concerns about planning for the future, the dangers of massive spending and deficit spending, and the domination of science by federal funding or by a

scientific-technological elite. He delivered his speech on January 17, 1961, in a television broadcast from the Oval Office of the White House. The immense military establishment and the large arms industry having unwarranted influence and power has occurred.

They Control The News Networks



The U.S. government brought over Hitler's propaganda experts. According to declassified records and interviews, the CIA and other United States agencies employed at least a thousand Nazis as Cold War spies and informants after World War II. Law enforcement and intelligence leaders like J. Edgar Hoover at the FBI and Allen Dulles at the CIA aggressively recruited onetime Nazis of all ranks as secret, anti-Soviet "assets". The Deep State Is Behind The Healthcare Crisis



Concerning the healthcare industry, I once read, A patient cured is a customer lost. I also read A society that keeps cures a secret, so they can sell medication is not a real society but a mental institution. According to a team of College of Medicine researchers at Penn State University, care for the 15 most prevalent types of cancer in the U.S. cost approximately \$156.2 billion in 2018, with drugs being a leading expense. The National Cancer Institute (NCI) reports that the medical costs of cancer care add up to some \$125 billion, with a projected 39 percent increase, to \$173 billion, by 2020. The cancer industry certainly qualifies as “big business”.

Royal Raymond Rife was an American inventor who developed a theory that targeting bacterial cells with electromagnetic energy at a frequency determined by the organism’s own unique energy frequency would create a cell-shattering resonance. He believed that cancer-causing viruses and bacteria had specific frequencies and that killing these pathogens would destroy the cancer cell along with microbes. elements of “organized medicine.” Royal Raymond Rife was born on May 16, 1888, and died on August 5, 1971, at the age of 83. He died of a heart attack at Grossmont Hospital. At the time of his death, he was living alone in an El Cajon rest home and was virtually penniless.

The cost of a single chemotherapy treatment can vary greatly, and there is no standard cost. Rough estimations can range from \$10,000 to \$200,000. The cost usually depends on factors such as the type of chemotherapy, the frequency, and duration of the treatment, the drug doses administered, the institution where the procedure is performed, and the patient’s residence. For many medicines.

Oncologists receive a 6% markup, meaning when they infuse a patient with a \$10,000 monthly course of chemotherapy, their practice yields an extra \$600. So the doctors make a minimum of \$600 per treatment. The oldest class of chemotherapy drugs actually derived from mustard gas, a poison the Germans used as a chemical weapon during World War I. After World War I, medical researchers noticed that mustard gas destroyed lymphatic tissue and bone marrow and thought it might also be able to kill cancer cells in the lymph nodes. Experiments in mice later showed that topically applying nitrogen mustard, which was derived from mustard gas, caused tumors to shrink. Nitrogen mustard was incorporated into multidrug chemotherapy for Hodgkin's disease and remains a potent agent against cancer today. Chemotherapy can cause a range of side effects. Some of the most serious side effects include infection and a weakened immune system, easy bruising and bleeding, and nerve pain. Chemotherapy can also damage cells in the heart, kidneys, bladder, lungs, and nervous system. I read of a doctor several years ago who had specialized in cancer treatment for 17 years and quit. He was tired of the hypocrisy. He claimed studies that proved chemotherapy was 90% ineffective. This treatment does not work and is all profit driven. He started doing talk shows and is a strong advocate of holistic medicine. There are ways to change the body chemistry from acidic to alkaline, it is much more difficult for cancer to survive in an alkaline environment. He’s a strong advocate of exercise, oxygen, and vitamin therapy.

Rick Simpson is a Canadian engineer and cannabis activist. He developed a cannabis oil product called Rick Simpson Oil (RSO) which contains higher levels of tetrahydrocannabinol (THC) than other medical cannabis extracts. After being diagnosed with skin cancer in 2003, he began applying RSO to the cancerous spots on his face and neck. According to Simpson, the spots healed within a few days. From 1850 to 1936 Cannabis was used as the primary medicine for more than 100 separate illnesses and diseases in the U.S. According to the web sources. I found heroin, marijuana, opium, and cocaine were made illegal in the early 1900s for various reasons, *mostly related to economics and cultural prejudice rather than addiction or health risks.*

Some of the factors that influenced the prohibition of these drugs were: The association of opium with Chinese immigrants, who were considered a threat to the labor market and social order. The first anti-opium laws in the 1870s were directed at Chinese immigrants. The Harrison Narcotic Act of 1914 regulated the production and distribution of opiate-containing substances and was later used to prosecute doctors who prescribed opiates to addicts. The association of cocaine with Black men in the South, who were perceived as violent and aggressive under the influence of the drug. The first anti-cocaine laws in the early 1900s were directed at Black men in the South. Cocaine was also considered a threat to the economic interests of white employers and plantation owners. The association of marijuana with Mexican migrants and Mexican Americans, who were blamed for social problems and crime. The first anti-marijuana laws, in the Midwest and the Southwest in the 1910s and 20s, were directed at Mexican migrants and Mexican Americans. Marijuana was also demonized by media campaigns that linked it to violence, insanity, and moral decay. All could not be arrested for cheap labor, but can now for illegal drugs.

John D. Rockefeller became America's first billionaire in 1916. He was the top oil tycoon of the 19th century, and his savvy business decisions made him tremendously wealthy. He was instrumental in the founding of the pharmaceutical industry. Furthermore, he then came across the idea of using coal tar, a petroleum derivative, to make substances that affect the human mind, body, and nervous system. These drugs were excellent at masking or stopping symptoms, but overall did not cure the underlying cause of a disease. Rockefeller then bought out part of the massive German pharmaceutical cartel, I.G. Farben. He wanted to eliminate the competitors of his new-found investment. So he hired a man called Abraham Flexner to submit a report to Congress in 1910. This report "concluded" that there were too many doctors and medical schools in America and that all the other healing methods which had existed for hundreds or thousands of years were unscientific quackery. Congress acted upon the conclusions and made them law. Doctors were jailed and hospitals defunded who did not agree with Rockefeller. Before the establishment of the pharmaceutical industry, everything was holistic.

Prescription drugs: All formally accepted prescription drugs are damaging for your health and are based on hiding symptoms only, rarely solving the problem that generated the illness (if any). They Are Behind Human Trafficking And Child Sexual Abuse



Trafficking in Human Beings (THB) is not only one of the most abhorrent crimes challenging international security today, it is also one of the most complex ones. There are an estimated 24.9 million adult and child victims worldwide, facing various heinous forms of trafficking, including for the purposes of sexual exploitation, labor exploitation, forced criminality, and organ removal. The annual profits generated by these crimes add up to an estimated USD150bn. Most alarmingly, THB goes widely unpunished, with States implementing very few prosecutions and even fewer convictions.

At the time of writing, the crisis resulting from the Covid-19 pandemic threatens to make the already abysmal global THB situation worse. There have been numerous reports of child sexual abuse cases in the Catholic Church. For example, a report from the Maryland Attorney General detailed allegations from more than 600 victims against more than 150 priests and others associated with the Archdiocese of Baltimore. The Catholic Church has been embroiled in child sex abuse scandals for more than two decades that encompass hundreds of thousands of victims and that span the globe, from Australia to Chile.

There have been reports of child sexual abuse by UN peacekeepers. An Associated Press (AP) investigation revealed in 2017 that more than 100 United Nations (UN) peacekeepers ran a child sex ring in Haiti over a 10-year period, and none were ever jailed. During Trump's Presidency, numerous D.U.M.B. bases were closed. D.U.M.B. stands for Deep Underground Military Bases. According to some researchers, these are secret bases used for Unacknowledged Special Access Programs and deep-state activities, including human trafficking and child abuse.

The Suppression Of Free Energy



Nikola Tesla was a Serbian-American inventor, electrical engineer, mechanical engineer, and futurist. Best known for his contributions to the design of the modern alternating current (AC) electricity supply system. He was born on July 10th, 1856 in Smiljan, Austrian Empire (modern-day Croatia), and died on January 7th, 1943 in New York City.

Tesla made dozens of breakthroughs in the production, transmission, and application of electric power. Nikola Tesla had a dream of creating a source of inexhaustible, clean energy that was free for everyone. He believed that the Earth had “fluid electrical charges” running beneath its surface, that when interrupted by a series of electrical discharges at repeated set intervals, would generate a limitless power supply by generating immense low-frequency electrical waves. Tesla also had an idea for a free energy device that accessed an unlimited source of energy with an antenna wired to one side of a capacitor and a ground wire placed into the earth wire to the other side. The positive solar radiation and the negative ground charge came together to create energy. However, his grand vision was never fully realized.

Thomas Edison and Nikola Tesla had a complex relationship that went from a business partnership to a bitter rivalry. The dynamic between the two inventors is pivotal to the origins of electric power. Edison was primarily a businessman and tycoon, mass marketing low current DC power to the public. Tesla, on the other hand, favored alternating currents. Rather than work together with Tesla to see if his ideas were viable, Edison instead refused the idea and drove him away. When Tesla found investors who believed in his tech and he began to gain attention and fame, Edison set out to defame and discredit Tesla. To prove that Tesla was wrong, he used his high-voltage systems to demonstrate to public animals that AC was too dangerous and deadly. Wireless energy transmission. Nikola Tesla also experimented with wireless power transmission, a technology with the ability to transmit electrical power without physical connections. His work led to the development of the Tesla coil, an electrical resonant transformer that can generate electromagnetic fields and transmit power

wirelessly. This technology is still the basis for wireless charging of electronic devices today. According to some theorists, free energy suppression (or new energy suppression) is a theory that technologically viable, pollution-free, no-cost energy sources are being suppressed by the government, corporations, or advocacy groups. Devices allegedly suppressed include perpetual motion machines, cold fusion generators, torus-based generators, reverse-engineered extraterrestrial technology, and other generally unproven, low-cost energy sources.

The Wardenclyffe Tower, also known as the Tesla Tower, was an early experimental wireless transmission station designed and built by Nikola Tesla on Long Island in 1901-1902. However, his decision to increase the scale of the facility and implement his ideas of wireless power transmission to better compete with Guglielmo Marconi's radio-based telegraph system was met with a refusal to fund the changes by the project's primary backer, financier J. P. Morgan. Additional investment could not be found, and the project was abandoned in 1906, never to become operational. In short, while Tesla had grand plans for the Wardenclyffe Tower, it ultimately did not work as intended due to a lack of funding. According to some sources, J.P. Morgan stopped funding Nikola Tesla's projects because Tesla's aspirations to provide free energy conflicted with Morgan's goal to dominate the power market. Morgan subsequently demanded a 51% stake in Tesla's Wardenclyffe project in exchange for funding other projects, and then cut off funding for all future Tesla projects.

The Assassination Of John F. Kennedy



John Fitzgerald Kennedy became the elected president. Following are excerpts from a speech he gave. This is the speech that caused the “elite” to assassinate him. JFK's speech on April 27, 1961, at the Waldorf-Astoria Hotel in New York City, where he addressed the American Newspaper Publishers Association. He said: “We are opposed around the world by a monolithic and ruthless conspiracy that relies primarily on covert means for expanding its sphere of

He also urged the press to exercise responsibility and discretion in reporting on national security matters and to cooperate with the government in protecting the public interest. He said: "Without debate, without criticism, no Administration and no country can succeed, and no republic can survive. That is why the Athenian lawmaker Solon decreed it a crime for any citizen to shrink from controversy. And that is why our press was protected by the First Amendment, the only business in America specifically protected by the Constitution, not primarily to amuse and entertain, not to emphasize the trivial and the sentimental, not to simply "give the public what it wants", but to inform, to arouse, to reflect, to state our dangers and our opportunities, to indicate our crises and our choices, to lead, mold, educate and sometimes even anger public opinion."

George. H.W. Bush (Poppy) was instrumental in the killing of J.F.K. Chauffeur Bill Greer of the Secret Service was the assassin. There are still more than 14,000 classified documents related to President Kennedy's assassination that remain locked away at the National Archives. The release of these documents has been delayed several times, with reasons ranging from national security concerns to the COVID-19 pandemic. There has been a fierce bureaucratic war over the documents recently, pitting the Archives against the CIA, FBI and other agencies that want to keep them secret. President Joe Biden's administration released more than 13,000 records of President John F. Kennedy's assassination on December 15, 2022. With this action, about 98% of all documents related to the 1963 killing have now been released and just 3% of the records remain redacted in whole or in part, according to the National Archives. However, about 4,300 records remain redacted in part, and experts say there's no justification for withholding them to protect national security or intelligence gathering.

They Caused The Destruction Of The Fukushima Nuclear Plant



On March 11, 2011, a 9.0-magnitude earthquake struck off the eastern coast of Japan. The earthquake triggered a tsunami that swept over the main island of Honshu, killing more than 18,000 people and wiping entire towns off the map. At the Fukushima nuclear power plant, a gigantic wave surged over defenses and flooded the reactors, sparking a major disaster. Systems at the nuclear plant detected the earthquake and automatically shut down the nuclear reactors. Emergency diesel generators are turned on to keep coolant pumping around the cores. However, soon after, a wave over 14 meters (45.93 ft.) high hit Fukushima. The water overwhelmed the defensive sea wall, flooding the plant and knocking out the emergency generators. In the days that followed, the nuclear fuel in three of the reactors overheated and partly melted the cores, something known as a nuclear meltdown. The plant also suffered several chemical explosions which badly damaged the buildings. Radioactive material began leaking into the atmosphere and the Pacific Ocean, prompting

evacuations and an ever-widening exclusion zone. According to Japanese government officials, the Fukushima plant has been leaking about 100 metric tons of radioactive water into the ocean every day since 2011.

There have been several instances where massive quantities of dead fish have washed ashore. For example, giant quantities of dead fish washed ashore on the eastern coast of Oman. In Tampa Bay, at least 600 tons of dead fish were washed. In Alaska, millions of dead fish washed ashore. In the past ten years, there have been many instances of Dead Sea life washing ashore. In Tampa Bay, at least 600 tons of dead fish washed up along the shore. In southeastern Florida, scores of dead fish are ashore. In North East England, thousands of dead sea creatures washed up on beaches. Park employees were swiftly deployed to clean and bury the dead fish before they rotted in the noon heat on Friday, Mr. Frazier said. Brazoria County is located about 65 miles (104.61 km) south of Houston.

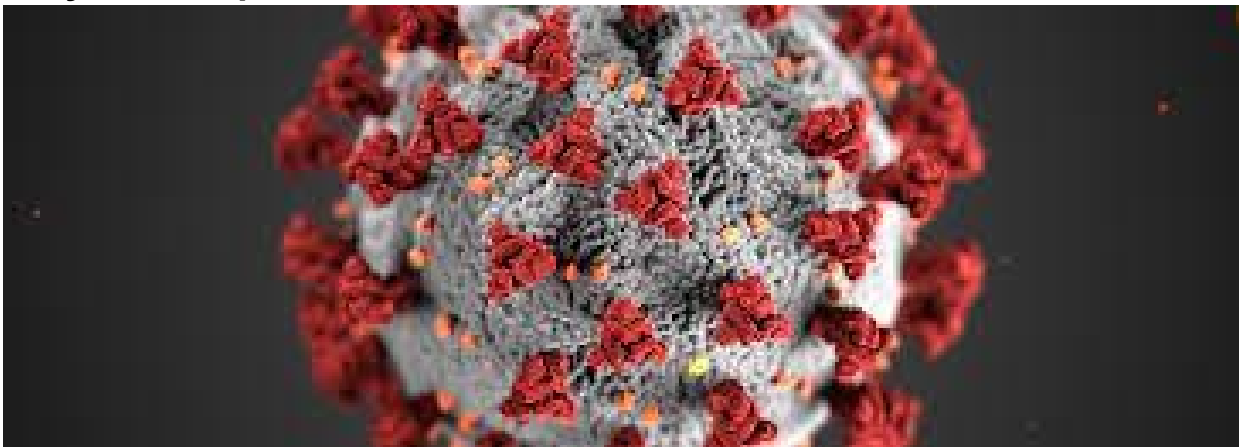

Zero Hedge is a financial blog and news aggregator that was founded in 2009. The blog is known for its pseudonymous posts, with the founder writing under the pseudonym “Tyler Durden,” a character from the novel and film “Fight Club.” The true identity of the founder and other contributors to the site is not publicly known. According to Zero Hedge, researchers in Wuhan, China working with the Chinese military were genetically manipulating the world’s deadliest coronaviruses to create a new mutant virus right around the time that the Covid-19 pandemic began, according to The Sunday Times, which has reviewed hundreds of documents, “Including previously confidential reports, internal memos, scientific papers and email correspondence that has been obtained through sources or by freedom of information campaigners in the three years since the pandemic started.” The Times also interviewed the US State Department investigators, including experts specializing in China, emerging pandemic threats and bio-warfare, who conducted what the outlet describes as “the first significant US inquiry into the origins of the Covid-19 outbreak.

The Mojiang mine shaft strain which killed several people are now recognized as ‘the only members of Covid-19’s immediate family known to have been existing pre-pandemic,’ and were transported to the Wuhan Institute of Virology.

Thereafter, “The trail of papers starts to go dark,” said one US investigator.

“That’s precisely when the classified program kicked off. My view is that the reason Mojiang was covered up was due to military secrecy related to [the army’s] pursuit of dual use capabilities in biological weapons and vaccines.”

According to US investigators, the WIV embarked on a classified program to make the mine shaft viruses more transmissible to humans, which they believe led to the creation of Covid-19, which then leaked into the city of Wuhan following a lab accident.

It has become increasingly clear that the Wuhan Institute of Virology was involved in the creation, promulgation, and cover-up of the Covid-19 pandemic,” said one of the investigators, who found evidence that researchers working on said experiments were hospitalized in November 2019 with Covid-like symptoms, just one month before the West became aware of the pandemic. One of the victims’ relatives died as well. “We were rock-solid confident that this was likely Covid-19 because they were working on advanced coronavirus research in the laboratory. They’re trained biologists in their thirties and forties. Meanwhile, a separate analysis reveals that the epicenter of the original Covid-19 outbreak was close to the WIV, not Wuhan’s “wet” wildlife market as previously thought.” I interviewed scientists in Asia who have close relationships with the Wuhan Institute of Virology,” said one of the investigators, who said they had evidence that the WIV was also working on a Covid-19 vaccine before the pandemic.

“They told me it is their belief that there was vaccine research going on in the fall of 2019, pertinent to Covid-19 vaccination.” Rutgers University microbiologist, Richard Ebright, called the experiments “by far the most reckless and dangerous research on coronaviruses, or indeed on any viruses, known to have been

undertaken at any time in any location.”

How The Deep State Is Being Defeated

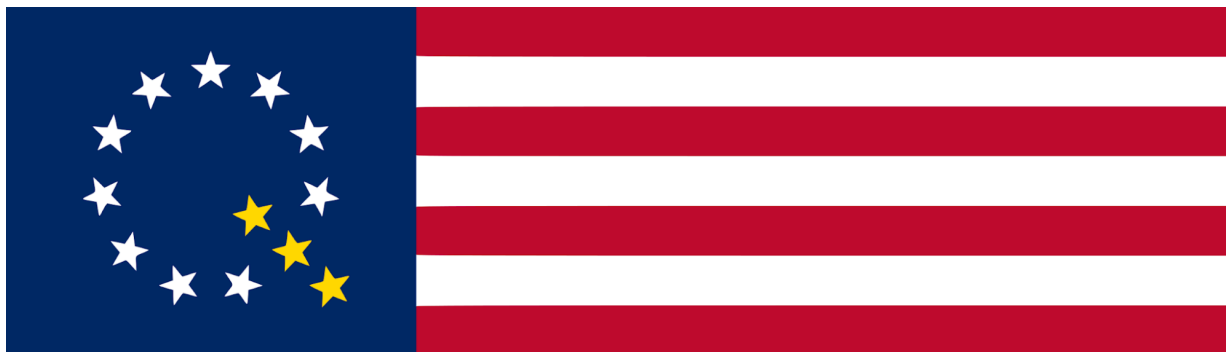

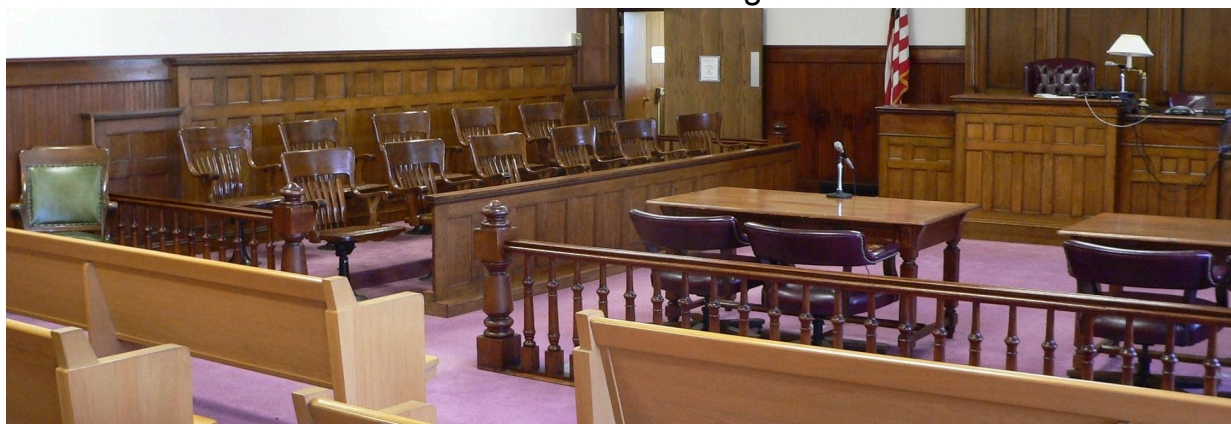

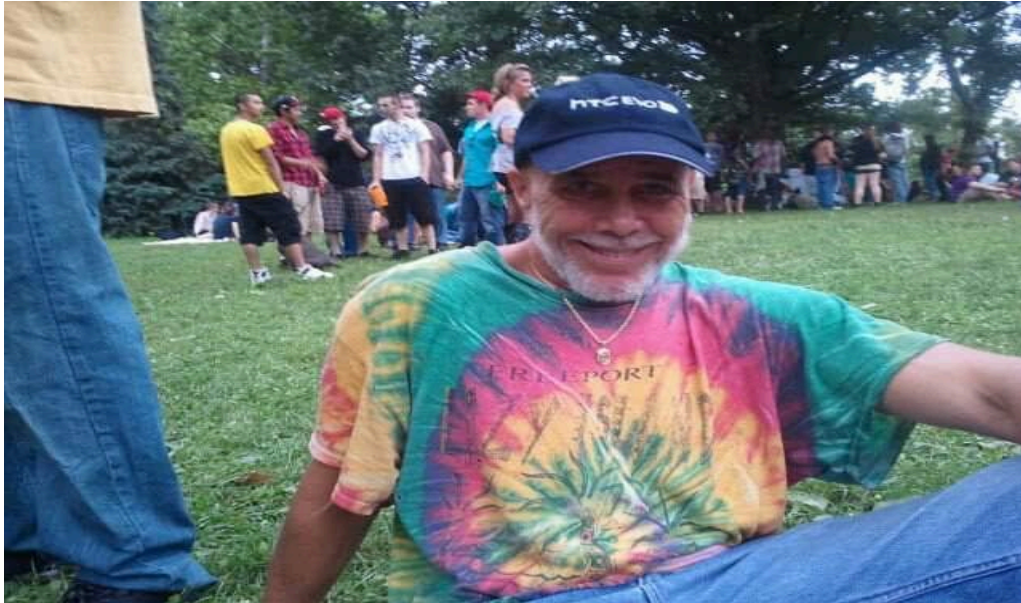
